



### **Terms and Conditions: Participation in Candela Academy**

### 1. Registration for the Event

- 1. Each Participant must register individually with a valid email address. Group registrations under a single email are not permitted.
- Valid registration for this event grants admittance as a Participant, subject to these Terms.
  Additional optional extras may incur an extra cost beyond the registration/package fee.
  Attendance will only be confirmed upon receipt of full payment.
- 3. Registration details of each Participant must be submitted before the start of the Event. We reserve the right to exclude any individual whose name is not on our register of Participants at the start of the Event.
- 4. When registering, provide accurate and complete Registration Details. It is the Participants' responsibility to update any changes to this information, including email address, by contacting us using the provided contact information in the Event Confirmation.
- 5. Please inform us of any special access or dietary requirements at registration.
- 6. All cancellations by Participants must be in writing and received **no later than August 1st, 2025.**Verbal cancellations are not accepted. Participants canceling after this deadline are liable for the full Fee. Participants may nominate a substitute attendee.
- 7. Attendance at the Event acknowledges the possibility of photography and filming. Candela or GSE the Agency reserves the right to use recorded images and videos featuring your photograph or likeness in future marketing materials, including social media, websites, and print, without further approval or payment.
